Whenever any new guidance is issued we will email you straight away with the information and relevant links.

Remember to keep up to date with our <u>Facebook page</u> which we keep up to date on a daily, we've recently added everything you need to know including posters to download for your settings.

Many childcare providers have been providing us with updates regarding their current situation, also highlighting where they may have places available for those keyworker parents who may need them.

This information has been crucial in providing alternative care at very short notice, enabling keyworkers to continue in their vital roles. Any keyworker parents needing a place are being directed to childinfo@bury.gov.uk.

Current figures indicate there are 71 providers open, some of whom could take additional children if needed, 122 are closed and 11 have yet been unable to inform us.

We are currently working on a short online form where providers can quickly update their status and this will enable us to process the data much quicker and provide a more streamlined service for all. All providers will be notified as soon as this is available but in the meantime should continue to send any updates to childinfo@bury.gov.uk. Once the form is in place we ask that you continue to complete this to notify us of those changes

The Executive Director of Childrens Services- Karen Dolton has recently sent out a letter to you in relation to new COVID 19 legislation, and also in response to some of the letters you have sent in.

The letter also served to consult with you on the current situation regarding supply and demand of childcare places, as she is fully aware of the very difficult balance you have in providing a vital service for those who need it whilst being economically viable.

Whilst there has been a suggestion around setting up childcare hubs, there is no current evidence to support this in Bury although this may be a discussion that we need to have with you going forward.

Where financial and business support may be required to sustain the continued provision, Bury Council have a single point of contact you may wish to access-investin@Bury.goc.uk, where advice, support and signposting is available. This is in addition to the government support

The latest government update is really focused on the importance of vulnerable children and the best ways in supporting them into education.

The following is an extract from guidance issued by the DfE:

There is an expectation that vulnerable children who have a social worker will attend an education setting, so long as they do not have underlying health conditions that put them at severe risk. In circumstances where a parent does not want to bring their child to an education setting, and their child is considered vulnerable, the social worker and education setting should explore the reasons for this, directly with the parent.

In the section below (EYFS) I wanted to share with you some plans we have around supporting young vulnerable children who may not be in provision, but also to ask if you have any ideas, good practice that you can share around how you are continuing to support both children and families who you may consider to be vulnerable.

Information re Food boxes

If you have any families that require a food box /parcel can you direct people to the early help inbox (earlyhelp@bury.gov.uk) to make their request with name, address and number of children.

Early Years Foundation Stage

The Early Years Foundation Stage (EYFS) sets the standards for the learning, development and care of children from birth to 5 years old.

The Early Years Advisors are now linked to locality areas and have made attempts to introduce themselves to you, please contact them direct if you would like telephone advice, support or just wanting to share with them some ideas you have around your practice.

They will also be prioritising their time in the next month or so working with social workers in Bury, supporting vulnerable children and families in providing a virtual offer so we can retain the focus around school readiness through these uncertain times.

In October 2019, The Department for Education (DfE) launched a public consultation seeking views on changes to the statutory framework for the EYFS. The consultation includes proposed changes to the educational programmes, the early learning goals and the EYFS profile assessment.

Communication and Language Development

As most of you may be aware we are currently working on developing our Speech, Language and communication Pathway across Bury.

We have been working closely with our partners in schools, health, and the PVI sector to align the work we do across Bury for young children's speech, language and communication, and ensure all our children across Bury have access to early intervention.

We now have an extra 64 schools/settings trained to deliver <u>Wellcomm</u> across Bury, and an additional 1481 children have been screened using the Wellcomm tool.

We have set up links on <u>The Bury Directory</u> to support good practice around speech, language and communication development, and are hoping to develop a specific page for "Communication Champions" to access resources all in one place. This should be available very soon.

Our Communication Champion Networks started on 09/03/2020, and more are planned for later in the year. If you would like more information on the project, or the role of the Communication Champion please contact Sharon Walton or Sam McLaren on 0161 253 6436/5087
